MEMO

In connection with the Bye Elections to Ward No. 82 of Kolkata Municipal Corporation scheduled to be held on 6th January, 2019, vide Notification No. 2748-SEC/1E-93/2018 (Pt.II) dated 13.12.2018 of the West Bengal State Election Commission, the undersigned is directed to say as follows :

- i) Since the date of poll on 6th January, 2019 falls on Sunday, which is a public holiday under the N. I. Act, 1881, separate order declaring the said date as a holiday for State Government offices, Undertakings, Corporation, Boards, Statutory and Local Bodies, Educational Institutions Etc. under the control of the State Government situated within the polling area of that Ward is not necessary.
- ii) For the Educational Institutions/Government offices etc. which will be used as Polling Stations and / or Distribution-cum-Receiving Centre, local holiday may be declared on the day preceding the date of Poll, i.e., 5th January, 2019 (Saturday).
- iii) Labour Department will issue suitable instructions to shops, commercial and industrial establishments to declare the said date for the concerned polling area as paid holiday for the workers to enable them to exercise their franchise in the election.
- iv) If the poll process continues upto the late hours on 6th January, 2019 resulting in the late release of Polling Personnel from Reception Centre rendering it difficult for them to attend the office in time on 7th January, 2019, special leave may be allowed to such employees for 7th January, 2019, in consideration of the situation stated above.
